Haddii aad ka cabanayso ka reebista qoys fiqiiir ah (waxa aad saxday “haa” laynka 2):

Waa inaad liistaysaa qof kasta oo qoyskaaga ah, oo ay kujiraan carruurta. Ku lifaaq bog dheeraad ah haddii ay jiraan in kabadan shan xubnood oo qoyska ah. waa inaad bixisaa qof kasta *dakhligiisa sannadlaha ah ee shakhsiyadeed* ee 2014 sannadka kaalandarka. Dhokumentiyi caddaymo ah ayaa loo baahday (eeg laynka 5)

Haddii aanad ka dacwoonayn ka reebista qoys sabool ah (waxa aad saxday “maya” ee laynka 2): liis garee kaliyaata dadka waaweyn kuwaasi oo ahaa da’da 18 ama ka weyna Diisambar 31, 2014.

- Sax “Helaha dakhliga” haddii shakhsigu uu haysto ugu yaraan \$1,000 oo ah dakhli cashuurmi kara sannadka kaalandarka ee 2014.
- Sax “dakhliga sannadlaha ah ee cashuurma kana yar \$1,000” haddii shakhigu uu haysto \$0 ilaa \$999.99 oo ah *dakhliga cashuurmi kara* sannadka kaalandarka ee 2014. Dhokumentiyi caddaymo ah ayaa loo baahday (eeg laynka 5)

④ Xaddiga guud ee cashuurta ee waajibka ahi waa \$35 laguna dhuftay tirada dakhli helayaasha ah eek u liistaysan foomka.

⑤ Waa inaad bixisaa dhokumentiyi caddaymo ah qof kasta kaasi oo aan bixin \$35 ee cashuurta ah. Shuruuduhu waxa ay ku xidhan yihiin cabashada dakhliga cashuur bixiyayaasha.

Haddii aad saxday haa ee laynka 2 (ka reebista qoyska saboolka ah): Ku lifaaq nuqul saxeexan oo ah foomkaagii faderaalka ee 2014 1040 (bogga 1 iyo 2). Haddii aanad awoodin inaad bixisosoo celintan (tusaale ahaan, adigu masuul kama tihid Foomka 1040 shuruudaha fayl garaynta), waxa aad siin kartaa nuqul ah waraaq hadyad ah oo ah dheefaha kaalmada dadweynaha ee SNAP (Barnaamijka Kaalmada Nafaqaynta Dheeraadka ah), ama TANF (Kaalmada Kumeel gaadhka ah ee Qoyska Baahan). ¹**Dakhliga sannadlaha ah** go'aan ka gaadhida ka reebista saboolka faderaalku waxa uu raacaa qeexida ay hirgaliyeen Waaxda Cilmi badhista Maraykanka waxana kujira dhammaan dakhligii laga helay meel uun sannadka kaalandarka ee 2014, iyada oo aan la eegayn haddii ay ku cashuurmayso sharci gobol ama faderaal. Tusaalayaasha dakhliga waxa kujira dheef ka timid shakhsi ama kaydka dad badan ama dheefo kale oo ah xisaabaha isbaddelay, bixinaha taageerada ilmaha, deeq, dakhliga naafada, kaalmda shaqo la'aanta, iibinta sheer iyo hanta kale (xataa haddii lagu iibiyo khasaare), saami, dakhliga Social Security (cashuurma ama aan cashurmin), risiidhada guud ee ka yimiday ganacsi ama gunnada shaqaale.

²**Shakhsiyadka qoyska** waxa kujira dhammaan dadka degan (dadka waaweyn iyo caruurta) kuwaasi oo leh guri kaasi oo fayl gareeya mid ahaan cashuur celinta faderalka ama gobolka.

³**Dakhliga cashuurma** waxa uu ka iman karaa gunnada, isku shaqaynta, maalgashiga (ayna kuirin Dheefta Hantida Maraykanka) kirada, hawlgabka (ayna kujirin Social Security, dhefaha Xeerka Ku caddaainta Hawlgabka faderaalka, Oregon PERS, FERS, and CSRS), naafada, bilaa shaqada, spousal/taageerada ilmaha, ama meel kale ayna magaaladu mamnuucin cashuur ka qaadisteeda.
